Reporting can take place on any private or public property you have permission to access.

Management, including pulling Himalayan balsam, should only be conducted on your personal property or acquisition of the proper authorizations and permission to access any land not owned by the participant is required. By submitting an entry to the digital entry form you are confirming you have read and understood the disclaimers and rules laid out in this document.

## **Rules**

There are two (2) contests in this project.

1. **Reporting Contest:** Any report of Himalayan balsam within the City of Sault Ste. Marie to [iNaturalist](#) will be entered for a chance to win one (1) of two (2) \$100 New North Greenhouse gift cards. The winner will be randomly selected and notified through the iNaturalist platform. Only residents of Ontario, Canada are eligible for entry into the contest.
2. **Management Contest:** Anyone who participates in one of the organized pull events as part of the SSM Himalayan Balsam Community Project or manages Himalayan balsam on personal property can enter for a chance to win one (1) of two (2) \$100 New North Greenhouse gift cards. The winner will be randomly selected and notified via the email address provided in the contest form.

Only residents of Ontario, Canada are eligible for entry into either contest. Following each draw the winner will be contacted via the provided email for notification and mailing address request to receive their prize. Only the winners will be notified.
